4. FIRST AID MEASURES

First aid measures**General advice**

Immediate medical attention is required.

Skin Contact

Immediate medical attention is required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes.

Eye contact

Immediate medical attention is required. Keep eye wide open while rinsing. Do not rub affected area. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes.

Inhalation

Call a physician or poison control center immediately. Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

Ingestion

Immediate medical attention is required. Do NOT induce vomiting. Drink plenty of water. Never give anything by mouth to an unconscious person. Remove from exposure, lie down. Clean mouth with water and drink afterwards plenty of water. Call a physician or poison control center immediately.

Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.
