GENERAL DESCRIPTION:

Specifically for Colored Linen. Stain Pro 2 reclaims challenging stains missed in the pre-spotting procedure, putting more linens back in service and ultimately saving money and time.

DIRECTIONS:

Use 1 packet per 60 lb machine. Open product bag and pour into empty washer. Product will fall into small holes in the drum, and will not be in direct contact with the linen. Load washer with items to be reclaimed. Washer should be filled to proper capacity to ensure adequate mechanical agitation, and optimal results.

SAFETY ON METALS:

Do not use this product on aluminum.

PRECAUTIONS:
